Clinical Training Opportunity for Treating Substance Use Disorders

A high-impact day of workshops providing case-based learning is being offered by the Wisconsin Society of Addiction Medicine on Saturday, September 29th in Madison. The workshops are designed for front line clinicians who have faced and will face the challenge of helping patients with substance use disorders. Clinicians who will benefit include primary care providers, emergency room providers, and other specialists, as well as NPs and PAs. Two morning and one afternoon options are available, including:

- The ASAM Treatment of Opioid Disorder Course: Focus on Buprenorphine (course participation requires four hours of online study prior to the live event; waiver qualifying requirements included)
- Naltrexone in Treatment for Alcohol and Opioid Use Disorders: Case Studies and Practical Applications
- Buprenorphine 2.0: I Have My X-DEA, So Now What? Case Studies and Practical Applications
